Welcome back NMU students, faculty and staff. It's hard to honestly say that much of this is being believe that it's already time to go back to school, but we all enjoy having you around and contributing to the great community that we live in. However, I do have to apologize for the state of some of our streets especially those around campus. We made every effort to be further along in the construction process but, typical of many construction projects, things happen to change the best laid plans. ## November General Election



The City Clerk's Office is busy preparing for the November General Election, scheduled for Tuesday, Nov. 7.

November's ballot will include contests for the Marquette City Commission and Marquette Board of Light and Power, as well as for Michigan's 109th State House seat.

In order to vote in November, citizens must be registered by Tuesday, Oct. 10. You can check your registration status online at www.michigan.gov/vote.

Absentee ballots are available through the City Clerk's Office, and will begin going out by Oct. 1. Questions can be directed to the Clerk at 906-228-0430.

Tourist Park Off Leash Area Reopening

The City's off-leash area, located at Tourist Park, is open to the public from Nov. 1 through April 30 each year. Anyone interested in obtaining an OLA permit can pick one up at the City Clerk's Office in City Hall. You must bring your current dog license. If you don't have a current dog license, the Clerk's Office can issue you one upon presentation of an up-to-date rabies vaccination certificate. Dog licenses cost \$8 for one year and \$20 for three years (if the animal is not spayed or neutered, the cost is \$16 and \$40). All licenses expire with the rabies expiration and must be renewed each year unless a three-year license was purchased. Licenses are required by law for all dogs and cats whether or not they leave the house.

Annual fees for the OLA permits remain unchanged from the previous season, City residents will pay \$15 per dog and nonresident fees are set at \$20 per dog.

Part of this transition has


been the acquisition of the .Gov domain. To obtain the domain, the City had to undergo a verification process that certifies to the General Services Administration (GSA), an independent Federal Agency, that the entity requesting

the domain name is an actual government entity. It is impossible to obtain this domain unless you are a local, state or federal government and it adds a layer of security to our web presence. A .Gov domain ensures that you are at

a government site.

In an additional part of this transition, all City email domains have also been changed from "mqtcty.org" to "marquettemi.gov". For example, johndoe@mqtcty.org is now johndoe@marquettemi.gov. Any emails sent to the old addresses will forward to the new emails for the immediate future, but

please update all contact information you might have to ensure future errors are avoided.



### Classic Cars On Third

The Classic Cars on Third car show was held on Saturday, Aug. 19 on North Third Street in downtown Marguette. The event took place between Park Street and Ohio Street and had more than 160 entrants, from Model-T's to Rat Rods and other custom creations. The event was put together as a collaboration between the Marguette DDA and Bill and Tammy Dupras, owners of the Third Base Bar. The Dupras approached the DDA with the idea for the event, in remembrance of their daughter, Jessica Drummond, a victim of domestic violence. The Dupras wanted to hold this event as a fundraiser for the Women's Center. The Marguette DDA agreed to assist in putting on this event in conjunction with the Dupras, as they hold extensive knowledge about car shows. "The event was a great success," said Bill Dupras, owner of the Third Base Bar, "We couldn't be happier with the turn-out." Through the tireless fundraising efforts of the Dupras, along with entry fees and other sales, the Classic Cars on Third car show was able to raise \$13,029.54 for the Women's Center, in addition to \$4,000 donated directly to the Women's Center in remembrance of Jessica Drummond.

## DDA Implements New Parking Meters

The new on-street parking meters throughout Downtown Marquette are officially up and running! The meters have been installed as the next implementation phase of the Downtown Development Authority's (DDA) strategic parking management plan. The goal of effective parking management is to regulate parking spaces in a manner that ensures a percentage of spaces are available at any given time. Parking meters help to control turnover that is vital for maximizing the potential flow of customers to the downtown district's retail, service, and dining establishments.



approximately 366 modern parking meters feature smart technology, offering residents and visitors convenient payment options including coins, credit and debit cards and flexible stay times ranging from one to three to ten-hour parking depending limits on location. Parking time limits, rates, and enforcement are easily identified

on each meter's digital display screen and through additional meter signage. The parking rate remains at 50 cents per hour; however, users may insert 25 cents and receive a half hour of time for shorter stays. The resulting meter turnover will improve parking availability and accessibility for users enjoying downtown's businesses and amenities. For even more customer convenience, future plans also include offering "pay-by-phone" technology.

Parking meters are located on the 100 block of East Washington Street, the 100, 200 and 300 blocks of West Washington Street, the 100 block of East Main Street, the 100 block of West Spring Street, the 100, 200 and 300 blocks of West Baraga Avenue, the 100 and 200 blocks of South Third Street, the 100 block of North Third Street and the Commons Parking Lot. In addition, each public parking lot has several 10-hour meters for those who choose to stay longer than the two hour free parking provided.

Two pay stations are located in the lower level of the Bluff Street Parking Ramp and one can be found in the North Main Street Parking Lot. Motorists should utilize the pay station upon arrival by entering their license plate number and paying for the desired stay time before beginning their time in Marquette's Downtown District.

Parking throughout Marquette's Downtown District is enforced Monday through Friday, from 9 a.m. through 6 p.m., with complimentary evening and weekend parking. For those who live, work or spend extended periods of time downtown, rental parking permits are available from the DDA office, located at 203 South Front Street, Suite 1-B.

All parking meter and rental permit parking revenue is reinvested by the DDA into downtown's parking system for snow removal and improvements to parking lots, sidewalks, walkways, and lighting. The DDA works to accommodate all users of the parking system and provide management that will promote turnover of conveniently located parking for customers and clients wishing to do business in downtown. To encourage downtown business owners, employees and others that need long term parking to park in areas designated as such, rental parking permits are available for purchase through the DDA office for a quarterly fee. All parking rental revenue is used to maintain and improve the All parking to and walkways throughout downtown. ## Project to Honor Phil Niemisto

Eighty-seven year old Phil Niemisto is a beloved fixture in Marquette's downtown. On any given day, no matter the weather, Phil can be seen throughout downtown working to keep shop windows sparkling clean or planting and tending his flowers in the Washington Street Pocket Park. The park was recently named by the City Commission as the 'Phil Niemisto Pocket Park' to honor Phil's decades of volunteer efforts in our City. Adding an artistic rendition of Phil in the Park would be a lasting tribute to an individual who embodies all the attributes that are special about our community. Marquette's Downtown Development Authority (DDA) is currently leading a community fundraising effort to pay for the installation a life-size statue of Phil Photo by Jack Deo

in the park. The DDA has chosen local

artist and sculptor Earl Senchuk to create the piece. Senchuk will create and install an image of Phil that will capture Phil's distinctive attributes. According to Senchuk, "my goal and challenge is to capture Phil's

spirit including his mannerisms, attire, attitude." The and statue will be created with sustainable materials that will withstand inclement weather. The Niemisto sculpture will involve the same techniques that Senchuk uses in his Livina Tree works. The medium will be of concrete and steel. The process, according

than capturing his likeness, "Phil rarely sits down long enough to measure him so capturing Phil's likeness is no easy task."

The statue will provide the community with an accessible piece of public art that can be freely appreciated and experienced by all. The plan is for the likeness of Phil sitting on a bench in his Park offering an interactive opportunity for people to sit beside him. According to DDA Executive Director, Mona Lang, as of Aug. 25, \$6,100 of the \$10,000 budget needed for the project has been raised. The budget includes \$8,000 for the statue and an additional \$2,000 for an interpretive sign and landscape. Lang noted that the support from the community has been great with over 80 people

already contributing to the project. In addition, several businesses have conducted in-house fundraisers including Hot Plate Pottery and Art Studio and Ore Dock Brewery. The Delft Bistro will host a fundraiser on Sept. 17 from 3-5 p.m. Tickets are \$10 with all proceeds going

to the project.

The goal is to have the statue installed this October in coordination with the celebration of Phil's birthday. Lang stated that "this piece will be a gift from our community community our as honor to a common man and to remind us that we all make


## September Exhibits: Lali Khalid And Chuck & Jeanann Labelle

She uses her work as a tool to explore themes of diaspora, identity, family and home in her own life and the lives of people she photographs. Khalid invites you to see her images in this exhibition without a predetermined perception. You will get glimpses of a continually evolving narrative, but the images do not give away the full account - "It is on you to find the veiled stories"
