Marquette Residents Donate \$6,500 to Sister City for Disaster Relief

Reacting to the news of the Great East Japanese Earthquake in the spring of 2011, City officials worked with the Marquette County Community Foundation to collect donations for relief efforts. Marquette’s Sister City, Higashiomi is located in the Shiga Prefecture of Japan and was not directly affected by the earthquake. When the 2011Marquette Delegation visited Higashiomi in October, they presented Hisao Nishizawa, Higashiomi mayor, with a check for \$6,500. Nishizawa recently responded by sending this letter to John Kivela, Marquette’s mayor:

“Thank you very much for sending \$6,500 for relief to victims of the Great East Japan Earthquake. We will make good use of your kind donation through the Japanese Red Cross Society.

It has been a year since the great disaster. Our City started helping by providing a drinking water supply and other basic necessities (pictured top right). We have been supporting by sending a public health nurse and other city hall staff, as well as by donating a mobile library (pictured bottom right). It will be a long way to support until those suffering from the disaster regain their normal lives. It will be appreciated if the citizens of Marquette continue to stand by us. I thank you and the people in Marquette.”

What does this mean to government in Marquette? At all levels, it means a period of change unlike any in recent memory. Consider that during 2012, in addition to the presidential election cycle, the clock is ticking on the automatic enforcement of the federal Budget Control Act (BCA) – the law Congress passed to cap discretionary funding and achieve additional deficit reductions. The law limits cuts in Medicare to up to 2%, and exempts many mandatory programs for sustenance and income assistance, while allowing for 5% mandatory cuts in most defense and non-defense discretionary programs, including education, housing, and others. Starting on January 1, 2013, the law will automatically create an across-the-board cut of 5% at EXACTLY THE SAME TIME as many Bush Era Tax provisions expire, and much of the remaining funding from ARRA reaches sunset as well. For the Marquette area, the anticipated economic impact will be a reduction of approximately \$10M, not counting any other program decisions (i.e., elimination of USOEK scholarships; fewer post offices, etc.).

At the State level, the federal changes will be felt as a series of eliminations and reductions that will be passed down to local jurisdictions. In addition, changes imposed by the adoption of the Economic Vitality Incentive Program (EVIP), as well as the potential elimination of the Personal Property Tax (PPT), could result in the reduction of revenue sharing/local tax capture by up to \$850K/annum.

At the local level, we must also add in the volatility of a year that may see changes in tax base due to the potential sale or closure of the Presque Isle Power Plant, and the potential sale of Marquette General Hospital to a for-profit corporation. While promising, final outcomes will remain uncertain as the proposals move forward through state and federal bureaucracies for most of the fiscal year.

Lacking any action by federal or state governments, the net result will be that on January 1, 2013, federal and state taxes may significantly rise at exactly the same time as revenue sharing and program spending will significantly fall. Local authorities (city and county governments, school boards, universities, etc.) will be left to figure it all out, and many will suffer from a lack of forward thinking.

In Marquette we’ve proposed a budget that DOES NOT RAISE TAXES, and continues a two-year trend of lowering long-term debt by 40% per annum, and decreasing the operational budget by 2.6%. We’ve done so in a manner that doesn’t rely on speculative revenue sources or other budget tricks – such as dipping into contingency funds. We’re proposing that we “hold our own” until changes at the federal and state levels are understood - and our community considers the limits imposed on local decision making.

Will the City maintain infrastructure investments, high-quality responsive services, and an outstanding quality of place that all residents enjoy? Yes. Will the City seek to expand partnerships and relationships that enhance the wonderful opportunities we enjoy? Yes. Marquette will endure and prosper – in spite of stormy seas.

McClellan Ave. Extension Project Schedule

The City of Marquette continues to make progress with the McClellan Avenue Extension Project, according to the City of Marquette’s Director of Planning and Community Development Dennis Stachewicz. “While some activities are slightly ahead of schedule, we still anticipate a September 25, 2012 date for the project’s completion,” he said. Weather may change the schedule, Stachewicz said, and major revisions will be announced to the media.

City Announces 2012 Elections

Elections are conducted annually in the City of Marquette for City elective offices (City Commission and the Board of Light and Power), as well as Marquette Area Public Schools.

There are two City Commission seats up for election and there are also two seats open on the Board of Light and Power. Our country will also elect the President of the United States and this is considered an even-year election where federal, state and county officials will also be elected. In addition, there is a strong possibility to have referendums for the public to decide.

The City Charter calls for nominating petitions to be filed for open seats on both the City Commission and the Board of Light and Power. Nominating petitions for these positions are available at the City Clerk's Office. Nominating petitions must be filed with the Clerk' Office by 4:00 p.m. Tuesday May 8, 2012, in City Hall at the City Clerk's Office.

City Budget and Public Hearing

With the City of Marquette's special budget meetings complete, the final phase will take place on Monday, May 14, 2012, when the City Commission will hold a public hearing in Commission Chambers at Marquette City Hall. The hearing is part of the Commission's regular meeting, starting at 7:00 p.m.

"Our staff did an excellent job with this year's budget preparations," City Manager William Vajda said. "The City Commission provided valuable feedback on the process this year, and most importantly, provided high praise for the proposed budget staff accomplished."

Because of uncertain revenue sharing from the state, the City decreased capital outlay expenses by over 60 percent; supplies and services are 8 percent lower; and the City's average annual bond debt over the past two years has decreased by approximately 40 percent.

Police Dog Honored, Two New Dogs Need Training

Nero, a member of the City of Marquette's K-9 Unit, was recently recognized by the Upper Peninsula Animal Welfare Shelter (UPAWS). Nero, a ten-year-old specially trained Belgian Shepherd, has been instrumental in fighting crimes and the illegal drug trade in and around Marquette.

UPAWS presented Nero with their Silver Tag Award (pictured below), given to an animal that "over a significant period of time, has performed a service for a person or persons," according to Reva Laituri, chair-person of UPAWS' awards committee. "Nero was nominated because of his service to the citizens of the City of Marquette and other communities in the Upper Peninsula," Laituri said.

"Over the years, Nero and Sgt. Munger have achieved many successes in drug detection and searches," said Chief of Police Mike Angeli. "They've also provided periodic drug checks at area schools, and their services have often been extended to other communities and law enforcement agencies as needs have arisen," Angeli said.



Nero's strenuous work and age have made him ready for retirement, Angeli said, and it will take two young dogs to replace him. Angeli said, "We're grateful for the public support that has made it possible to 'hire' Nero's replacements, but we now need to focus on obtaining the training and equipment we'll need to create a fully-functional unit," said Angeli.

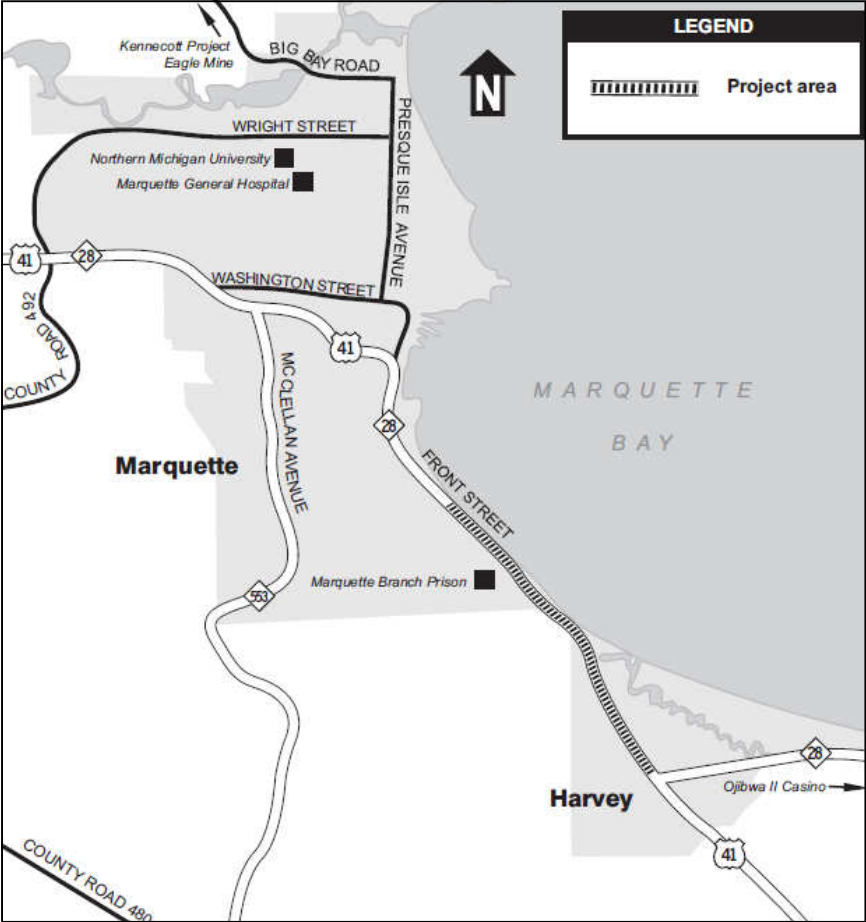
Road Improvements Made to US-41/M-28 South

This summer the Michigan Department of Transportation (MDOT) will be reconstructing US-41/M-28 from the Carp River in Marquette to Bayou Street in Harvey, as well as resurfacing the highway from Bayou Street to the US-41/M-28 intersection in Harvey. The project will also include construction of a multi-use pathway along Lake Superior.

The project will require lane closures with traffic shifts. However, one lane of traffic will be maintained in each direction. Temporary turn lanes will be maintained at driveways and roadway approaches. A temporary traffic signal is in use at the Marquette Branch Prison entrance. Access to businesses will be maintained at all times.

MDOT reports that this work will improve safety, ride quality and convenience for motorists and extend the pavement service life by seven to twenty years. MDOT's 2012 road and bridge program supports the creation of jobs, growth of the economy, preservation of the environment and the safety and security of the transportation system. Open Burning Prohibited

The City of Marquette Fire Department would like to remind residents that open burning in the City of Marquette is prohibited by City Ordinance #530. This prohibition is in compliance with parts 55, 115 and 515 of the State of Michigan Natural Resources and Environmental Protection Act 451 of 1994, as amended (Act 451), and associated administrative rules, including the following:

- Fires in fire rings and fire pits, or any open burning of materials
- Burning material in outdoor incinerators or burning barrels
- Installing and operating furnaces designed to provide heat in a separate structure
- Fires in raised outdoor fireplaces that are not directly associated with cooking food or fire of long duration.

Downtown Marquette Farmers Market Season to Open

The Downtown Marquette Farmers Market's Grand Opening will be held on Saturday, May 19, 2012. This year's Grand Opening will feature music by Jeff Nelson from 9:00 a.m. to 1:00 p.m. There may not be tomatoes and sweet corn yet, but the market will still have plenty of delicious food to offer, as well as a great

selection of vegetable and flower garden starts. In celebration of the local food that is available early in the growing season, the Marquette Food Co-op is sponsoring two food demonstrations that will use produce available at market that day. Cooking demonstrations will be held at 11:00 a.m. and at 1:00 p.m. by Abbey Palmer, who volunteers with one of the vendors, Rock River Farm. The Co-op and the Downtown Development Authority are also sponsoring a children's activity, and will supply soil and seeds for children to start seeds of their own to take home.

The market has a lot to celebrate this year. Two grants were awarded which will increase the community's access to fresh, healthy food. The USDA Farmers Market Promotion award of \$46,000 will be used to purchase tents for vendors, to purchase better facilities for the market information booth, and to provide funds for various types of market promotion. The second grant award was from the Fair Food Network, "a national non-profit that works at the intersection of food systems, sustainability, and social equity to guarantee access to healthy, fresh, and sustainably grown food, especially in underserved communities." The Downtown Farmers Market grant award is through the Double Up Food Bucks project. Under Double Up Food Bucks (DUFb), families who receive Supplemental Nutrition Assistance Program (SNAP) benefits are given the means to purchase more Michigan-grown fruits and vegetables at farmers markets while supporting local food growers and the local food economy. "Everyone deserves access to nutritious food," says market administrator Sarah Monte, "and Double Up Food Bucks helps make that access a reality for everyone in our community, regardless of income. Produce at the farmers market is already comparable to grocery store prices across Marquette, but this program makes shopping at the market even more appealing and directly supports our farming and artisan food community."

The market will be held every Saturday, rain or shine, from 9:00 a.m. to 2:00 p.m. until the end of October at the Marquette Commons, 112 South Third Street. Bridge Card, Market FRESH, Project FRESH, credit, and debit cards are all accepted. Bookings for music performers are currently underway at the market, and interested parties may call Sarah at 906-225-0671, ext. 23.

Blueberry Fest Vendor Registration Open

The Marquette Downtown Development Authority is pleased to announce that plans are underway for the annual Downtown Marquette Blueberry Festival, slated for Friday, July 27, 2012. 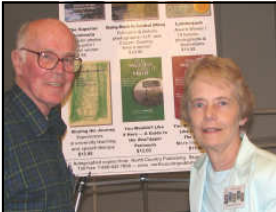

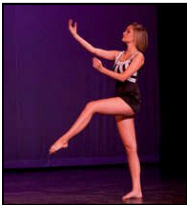

Skate Plaza Dream Soon to Become Reality

The Skate Plaza project is soon to be a reality! After seven years of planning, planning and more planning, the Marquette County Community Foundation and the Skate Plaza Committee is about to break ground in the triangular piece of land located in front of the YMCA at the corner of Pine and Fair.

In 2007 a group of community youth asked for help after being asked to leave the various City locations they skated at. They asked for a safe, legal place to practice their sport.

A group of concerned and interested citizens then gathered and the process of designing a park began. About 25 youth participated in a design process, sharing their dreams and thinking through safety and skating issues. The design the youth came up with was a skate plaza, which is essentially a concrete park with benches and features that can be skated on. A skate plaza takes the urban features most popular for skating and places them in one location. The park will be attractive to the public viewing it from the road of bike path; it will include green space and even skate-able art features.

Spohn Ranch, a company specializing skate plazas, was contracted to take the youth design and make it into a workable plaza. Hays Hitzing from Spohn Ranch says, "The plaza design created for Marquette will please every skater from the novice to the expert with a cutting edge plan." The diagram below details the park's design.

Several years of fund raising ensued and the Marquette County Community Foundation, with the Skate Plaza Committee, has nearly reached its goal. City of Marquette Flagship Named to National Register of Historic Places

An administrative change by the keeper of the National Register of Historic Places in Washington, DC, is cause for excitement in Michigan as the historic designation of what has become Marquette's flagship, *Coaster II* (pictured below), is transferred from the state of Washington to Michigan.

The two-masted schooner is a New England product, designed by master boat and yacht designer Murray Peterson of Marblehead, MA, and built in 1933. *Coaster II* was designed as a scaled-down replica of New England nineteenth-century coasting schooners but with modifications so that, as Peterson stated, "she could sail with the best of the yachts that

we were seeing near Boston." The schooner was listed in the National Register of Historic Places in 1989 when it was docked in Everett, Washington. By 2007, *Coaster II* had been relocated to Maine and was deteriorating. It was then that carpenter Niko Economides purchased the vessel. He and his son set about restoring *Coaster II*, and they eventually sailed it down the Atlantic seaboard, up the Hudson River, through the Erie Canal, and into the Great Lakes to a new home port in Marquette Harbor in Michigan's Upper Peninsula. In 2009 Economides and his family began offering charters through their business, Superior Odyssey.

"We've known for years that Marquette is filled with many treasures, and the *Coaster II*'s selection for this historic designation shows that our gems can be found on land and water," Marquette Mayor John Kivela said. "This designation makes Marquette the home port for the only National Historic Sailing Vessel on the Great Lakes. We're delighted that our 'traveling ambassador' has been recognized at the nation level."
