### Community Recycling Survey

## Message from Mike

A few things have changed—and rather quickly—here at the City since the last time I wrote this blog. At that time the current City Manager, Bill Vajda, was on vacation and I was filling in for him while he was out. By the time you read this, if all goes according to plan, I will be the new City Manager as Bill decided to move on.

After over 39 years with the Marquette City Police Department, the last thing I expected was to become the City Manager; however, circumstances dictated otherwise. I grew up in Marquette, attend the Marquette Area Public Schools graduating from Marquette Senior High School in 1973. I attended Northern Michigan University and, after finding my way, graduated with a Bachelor of Science degree in Law Enforcement with a minor in Business Management.

I joined the Marquette City Police Department in 1976, at the ripe old age of 21, and began my career as a Police Support Officer (PSO). It was a non-sworn (I didn't get to carry a gun or make arrests) position, but wore a uniform and worked with the regular officers on patrol. I joined the Police Department at a fortunate time as they were still sending new officers to the police academy. Myself and another PSO were sent to the academy at NMU in the fall of that year and the rest is history. I was apparently smart enough and good enough to move up through the ranks, eventually reaching the position of Chief in 2008.

I didn't make it alone, however. I came from good stock. My father and mother, Mike and Rita Angeli, owned and operated Angeli's Super Valu and eventually a small bakery in Marquette from 1959 until 1998 at the time of my father's passing. My mom still resides in Marquette and is quite active at 85 years old. Both of my parents were very active in the community which transcended down to their six children. I have been wonderfully supported by my wife of 32 years, also a lifelong resident of Marquette, the former Kay Levandoski. An interesting note here is that when we met, Kay worked for my dad at the Super Valu while I worked for her dad who was a Detective Lieutenant at MPD. Kay and I have two children, Mike III and Catherine. As you can probably imagine, life as a police officer is not always normal or easy and if not for Kay's commitment and understanding, I wouldn't have been able to grow. There was a lot of shift work, weekends and holidays worked, birthdays missed and many other events that would strain any family, but she (and the kids) made it work for us. And for that, I am thankful.

I had many good role models in the PD that I won't all mention here for the sake of saving space, but if I hadn't been hired by former Chief George Johnson, none of this would be happening. I never planned on being your City Manager, but I feel that I am up to the job and I hope to continue to represent this community well. Wish me luck.

## Welcome, Mr. Manager

As mentioned in his own article above, Mike Angeli has officially taken over the position of City Manager as of the Oct. 13 City Commission meeting. Mike has stepped into the position at a time of need for the City and has shown strong leadership and direction in continuing the projects and directives set forth by the Commission. He is on the cusp of celebrating his 40th year of service with the City, 32 as an officer and the past seven as an immensely popular Chief, and has been drafted into a career change that no one was expecting. Marquette needed a leader who was familiar with the landscape, the people, and the massive undertakings that are being attempted as this article is being published. Mike Angeli is now inexorably tied to this City and its history and we wish him the best of luck in his unorthodox retirement from a distinguished career of police service.

## Holiday Closure

City offices located at Marquette City Hall, 300 W. Baraga Ave.; the Lakeview Arena, 401 E. Fair Ave.; the Marquette Arts & Culture Center, 217 N. Front St. (Peter White Public Library); and the Municipal Service Center, 850 W. Baraga Ave. will be closed on Thursday and Friday, Nov. 26 and 27; Thursday and Friday, Dec. 24 and 25; and Thursday and Friday, Dec. 31, and Jan. 1, 2016, for the Thanksgiving, Christmas, and New Year holidays, respectively. The Fire and Police Departments will remain open and staffed during these times.

## Manager Open Office Hours

City Manager Mike Angeli holds community office hours on the second Wednesday of each month, from 10 a.m. until noon in the main floor conference room of the Peter White Public Library. The next community office hours sessions are scheduled for Nov. 11 and Dec. 9.

The meetings are intended to provide informal opportunities to discuss issues within the community, and to give citizens a chance for direct dialogue with City staff about interests and concerns.

## Winter Parking Ban

Marquette City residents, NMU students, and visitors are reminded the City's winter parking ban will be in effect beginning Nov. 1. The winter parking ban requires owners of vehicles to find off-street parking between the hours of 1 and 6 a.m. daily. The winter parking ban will be in effect until April 1, 2016. The fine for violating the parking ban is \$50. Marquette residents are encouraged to find alternate off-street parking before the parking ban goes into effect.

## November General Election

At the City General Election to be held on Nov. 3, City voters will elect two of four candidates that will serve three-year terms on the City Commission. Also, two of four candidates for the Board of Light and Power (BLP) will be elected to serve three-year terms on the BLP.

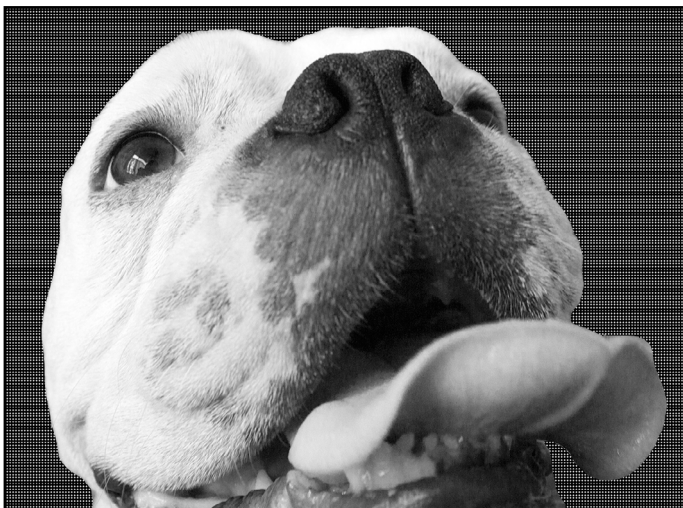

## Off-Leash Area (OLA) Registration

The City's off-leash area, located at Tourist Park, is open to the public from Nov. 1 through April 30 each year. There will be no OLA permit sales from Oct. 28 through Nov. 7 because of the November General Election. Anyone interested in obtaining OLA permits can register at the City Clerk's Office in City Hall and must bring your current dog license. If you don't have a current dog license, the City Clerk's Office can issue one as long as you have an up-to-date rabies certificate. Annual fees for the OLA permits are unchanged for the 2015-16 season with resident fees set at \$12 per dog and non-resident fees set at \$20 per dog.



## Water Meter Winter Access

Please take an extra few minutes to clear a path to your touchpad (shown below) as you snowblow, shovel, or plow your home or business. The water meter readers must physically touch the center of the touchpad with their electronic reader to obtain a reading. If this is not possible, your reading and bill will be estimated for that billing period. If your meter is located behind a gate that is normally kept locked or becomes snowed in during winter, please call Utility Billing at 906-228-0420 to have your touchpad relocated. There is no charge to have the touchpad moved.

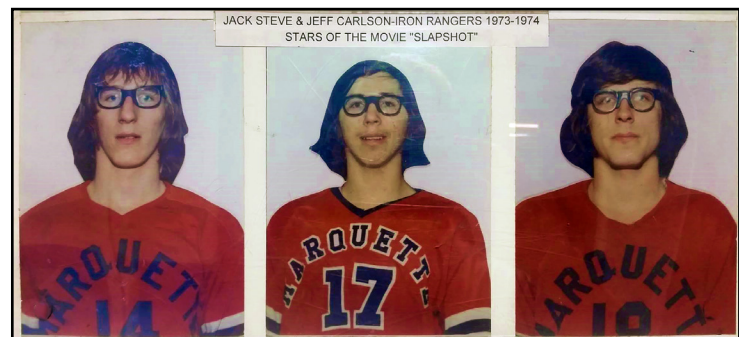

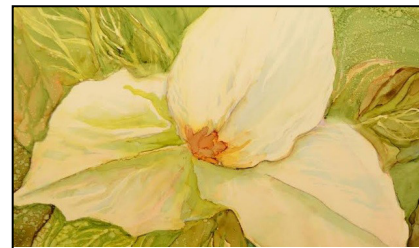

## Senior Center presents the Silver Sampler Program

The Marquette Senior Center in partnership with the Michigan Recreation & Park Association is excited to offer a very unique program for area seniors - The Silver Sampler. Community members ages 55+ will be able to take a "taste" of the best recreation opportunities in and around the City of Marquette at NO COST! As a pilot program, The Silver Sampler's goal is to support community members who hope to become more physically active, more involved in our beautiful outdoors, and experience more fully the exciting sports and activities that Marquette has to offer. The Silver Sampler will enable program members to "sample" both winter and summer activities under the guidance of experts and with the ongoing support of community mentors in safe and supportive small group venues.

The winter sampler will offer sessions in skating, cross country skiing, downhill skiing, snow biking, snowshoeing, fitness conditioning and fitness tracking via the Mystride activity monitor. The summer sampler will offer samples of kayaking, stand up

paddle boarding, rowing, tour biking and consultation on trail running and mountain biking. Fitness conditioning and fitness tracking will continue during the summer session. Members are encouraged to sample at least two offerings along with the fitness conditioning and fitness tracking, but may sample all of the offerings.

The Silver Sampler is now offering applications to participate in the Winter Sampler. The program is limited to 15 members. Applicants must be within the Marquette Senior Center service area (City of Marquette, Marquette Township, Powell Township, and Chocoley Township). Applicants should be in good general health with the ability to be comfortable in outdoor temperatures and venues.

## Medicare Open Enrollment

The Marquette Senior Center is pleased to announce that their social work staff will be offering Medicare/Medicaid Assistance Program (MMAP) assistance again this year. As MMAP counselors they are available to assist seniors in the Marquette Senior Center service area with important and often confusing decisions pertaining to health insurance. MMAP counselors are trained in health benefits counseling, including Medicare, Medicaid and other insurance products. The social work staff is not licensed as insurance agents and does not advocate for any insurance company. The social workers can help you:

Understand Medicare and Medicaid:

- Compare and enroll in Medicare Part D or Medicare Advantage plans.
- Review your Medicare Supplemental Insurance needs.
- Apply for Medicaid or a Medicare Savings Program.
- Determine Eligibility and apply for Low Income Subsidy Assistance.
- Identify and Report Medicare and Medicaid fraud, abuse, or scams.

Anyone who joined a Medicare prescription drug plan last year will soon receive an Annual Notice of Change from the company with which they have drug coverage. Please read this carefully, as this notice will identify whether the plan is changing their premiums, co-pays, deductibles, and/or the medications they will cover. You will need to make sure that the medications you are currently taking will still be covered by your plan in 2016. If you need help understanding the notice, call an MMAP counselor for assistance.



Beneficiaries should take the time to answer these questions:

1. Cost: Will your premium and costs change significantly in 2016?
2. Coverage: Do you need more coverage in 2016? Will the prescriptions you are taking be covered by your current plan in 2016?
3. Customer Service: Are you satisfied with your plan's service?
4. Options: Are there better plans available for my specific needs?

This year the annual enrollment period for Medicare prescription drug plans is Oct. 15 – Dec. 7. Everyone should have their plan reviewed at this time because of changes that may adversely affect your coverage. For those who have opted not to join a plan in the past, now is also the time to see if enrollment into a plan would be beneficial. For those seniors who are turning 65, the social work staff can assist you with understanding your options and provide you with the background information you will need to enroll for the first time.

## Help Feed A Hungry Neighbor

The Marquette Senior Center is teaming up with TV 6 to Help Feed A Hungry Neighbor. Drop boxes are placed throughout the Senior Center for your non-perishable food donations.

Last year, over 142,000 pounds of food was donated in 10 Upper Michigan counties. Since the event began in 1982, the people of Upper Michigan have donated over 3.19 million pounds of food to their local food pantries. The food stays in the communities in which it is collected, with the goal being to help feed a hungry neighbor.

## That Time Again, Winter Tax Bills

Property taxes are billed in two installments, July 1 (summer taxes) and Dec. 1 (winter taxes).

Winter tax bills will be mailed to Marquette City property owners Nov. 30 and tax collection begins Dec. 1, 2015. Payments are accepted at the City Treasurer's office without penalty through Feb. 14, 2016 after which a penalty of 3% is added to the winter tax bill. On March 1, all taxes become delinquent and are assessed additional penalties. Real property taxes are transferred to the County Treasurer for collection and personal property taxes (business) are retained by our office.

The 2015 winter property tax bill represents millage levies for Marquette County Transit, County Aging, County M.O.E., County Dispatch, County Rescue, and County Veterans Affairs.

For property owners you can look up current tax information free of charge. You will need to set up an account before accessing Assessing or Current Tax menu. Non-property owners can access the information for a \$2.00 fee per property.

The City Treasurer's office takes payments in cash, check, credit card, and e-checks.

Credit card payments can be made in the office along with cash and check, by phone you can use credit card by calling 1-855-246-9466 or by going to [www.mqtcty.org](http://www.mqtcty.org) – click on the Property Lookup & Online Payment on the left hand side.

These payments are subject to the following fees:

Credit Card:

3% convenience fee with a \$2.00 minimum.

E-Check: \$3.00 fee for up to \$9,999.99

\$10.00 fee for \$10,000.00 and over

Taxpayers may also apply for automatic payment of the taxes; forms are available on the website [mqtcty.org](http://mqtcty.org) or in the office.

## Thanksgiving Safety



Stay in the kitchen when you are cooking on the stovetop so you can keep an eye on the food.

Stay in the home when cooking your turkey and check on it frequently. Keep children away from the stove. The stove will be hot and kids should stay three feet away.

Make sure kids stay away from hot food and liquids. The steam or splash from vegetables, gravy or coffee could cause serious burns.

Keep the floor clear so you don't trip over clutter.

Keep knives out of the reach of children.

Be sure electric cords from an electric knife, coffee maker, plate warmer or mixer are not dangling off the counter within easy reach of a child.

Keep matches and utility lighters out of the reach of children (i.e. up high in a locked cabinet). Never leave a room with a lit candle.

Make sure your smoke alarms are working. Test them by pushing the test button.

The Marquette City Fire Department urges extreme caution in the use of outdoor gas fueled turkey fryers that cook the turkey in hot oil. The use of turkey fryers can lead to devastating burns, other injuries, fires, and the destruction of property.

Moving forward, the City will maintain and clear the road and bike path year-round with only short term closure as needed.

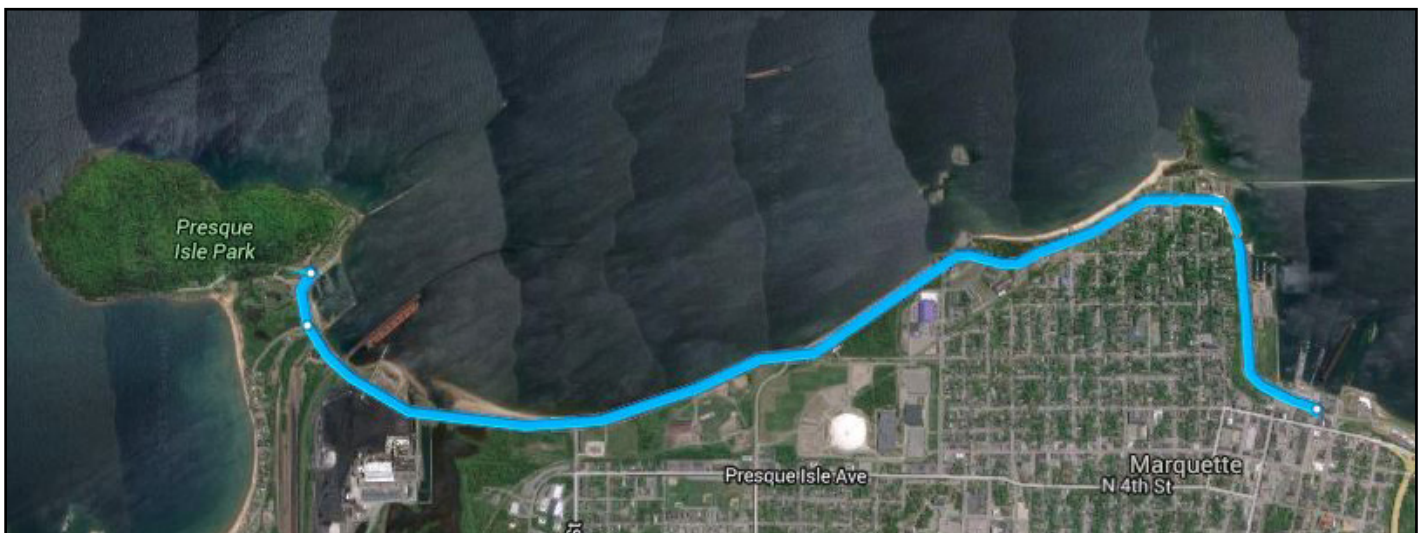

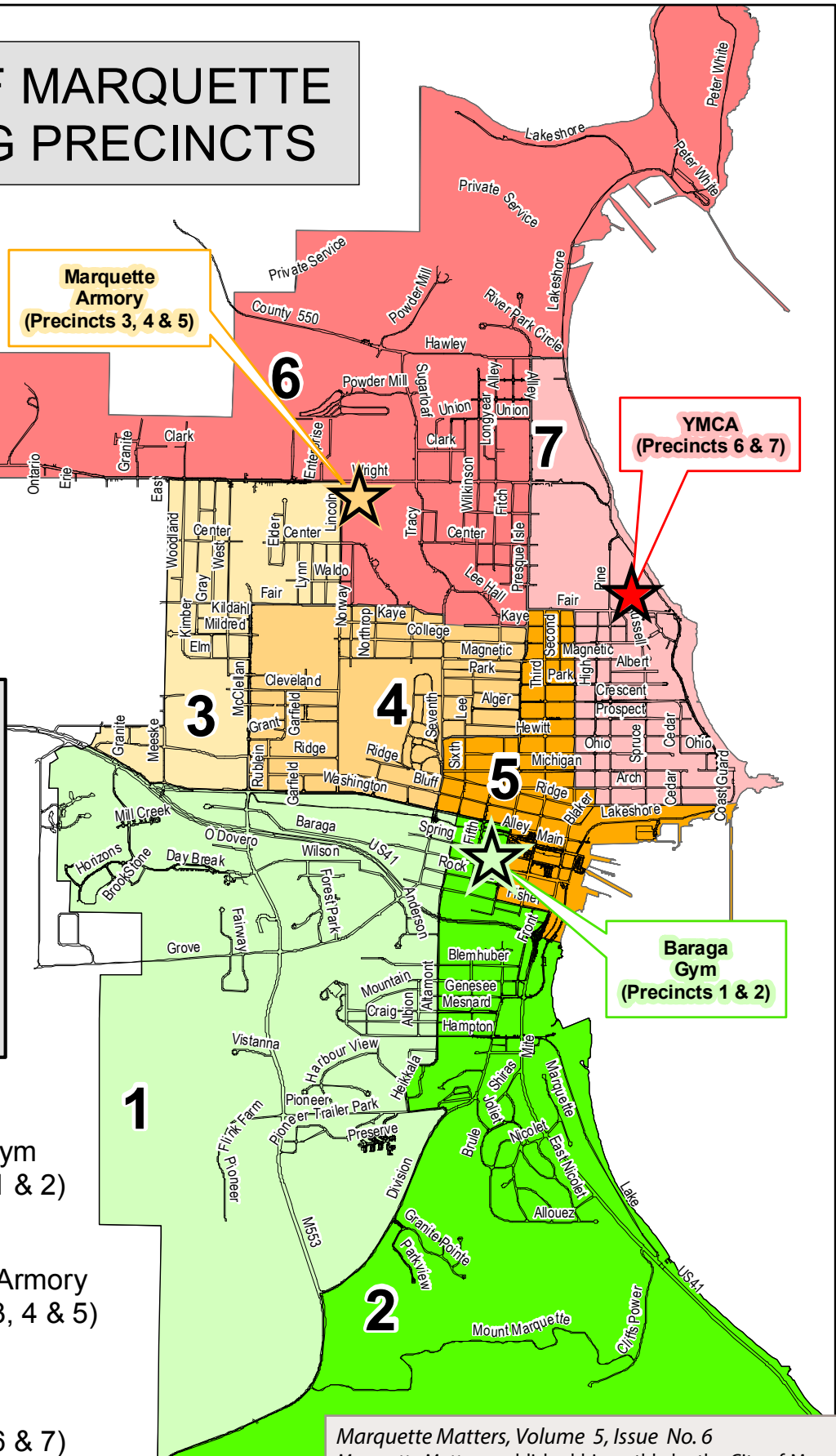
