Welcome back students and especially those that are new to NMU. Marguette is a bustling place and, because the summer is not quite over, many areas of construction still exist. For example, there is still some significant road work on Presque Isle Avenue and in Presque Isle Park that I'm sure will affect your day.

Speaking of Presque Isle Park, this is a popular destination for old and newcomers alike. Especially Black Rocks, where jumping from the high rocks into Lake Superior has become somewhat of a rite of passage and leads me to mention the perils of Lake Superior. Please take the time to familiarize yourself with the lake and its potential dangers. The locals are well aware, but sometimes the draw of its beauty underscores the lakes awesome power that is often not evident at first glance. So please take the time to learn before you leap. As a side note, you might want to pay attention to parking restrictions in that area as well.

Late summer and fall continue to be a busy time for us here at the City. Due to the short construction season, we are often hurrying to finish projects while planning ahead for the next season. This area is likely to see light industrial use and some new housing as well. In any case, my thanks to all for living in or just visiting our fine City and I hope you enjoy your time here no matter your interests.

# Manager Open Office Hours

# Rental Inspection Reminder

City Code (Ordinance #667) requires all rental dwelling units to be registered, inspected and certified with the City of Marquette. Any structure or dwelling unit that is occupied by persons other than the property owner, pursuant to any oral or written rental or lease agreement or other valuable compensation, is considered a rental dwelling unit. Rental properties are required to meet City Code requirements for fire safety as well as Zoning Ordinance requirements.

New long-term rentals (30 days or more) must be registered prior to any occupancy. Currently rented long-term rentals that change ownership must be registered by the new owner within 30 days of purchase.

Short-term rentals (less than 30 days) must be registered, approved, inspected and certified prior to advertising or use as a short-term rental.Proximity restrictions apply for all short-term rentals.

## City Developing a Stormwater Management Plan

The City, in partnership with GEI Consultants, Inc. and the Superior Watershed Partnership, is developing a comprehensive Stormwater Management Plan (SWMP) with the assistance of a Michigan Department of Environmental Quality Stormwater, Asset Management, Wastewater Grant. The key plan components include preparation of an operational and maintenance manual, non-point source pollution mapping and a Whetstone Brook stream evaluation. The ultimate goal of a Stormwater Management Plan is to provide a roadmap to improve water quality and to reduce flooding throughout the City. A benefit of the SWMP is that the information provided can assist in future grants to protect one of Marquette's greatest assets, Lake Superior. The Stormwater Management Plan will be available on the City website this fall. As a part of the SWMP, the City and the Superior Watershed Partnership will be providing additional stormwater education



resources for City residents and business owners over the coming months. Stormwater is the rain and melting snow that runs off lawns, roofs, roads and parking lots and into watersheds. In Marguette, virtually all of this stormwater ends up in Lake Superior either through natural drainage or through the stormwater drains you see along the roadside. There are over 3,000 storm drains in Marguette. In addition to field projects, volunteer events and school activities, look for a series of articles on what you can do to help keep our stormwater as clean as possible. Topics include; around the house, lawn and garden care, pet waste, water conservation techniques, reducing cigarette butt litter and new community engagement opportunities. These educational articles will be printed locally and will also be available on the City website (marguettemi.gov) and the SWP website (www.superiorwatersheds.org). Remember stormwater is a resource we all need to protect!

## City Wrapping Up 2018 Beach Monitoring

As part of the Beaches Environmental Assessment and Coastal Health Act of 2000 (Beach Act), the Environmental Protection Agency, in partnership with state and local governments, provides grant funding to monitor the nations beach water quality. Since the implementation of the Beach Act, the City of Marquette has annually conducted beach monitoring at the City's five beaches which include: Tourist Park, Clark Lambros' Beach Park, North Beach, McCarty's Cove and South Beach.

Each season, water quality is monitored for e. coli, the indicator of potential risk to swimmers. The maximum allowable e. coli count is a mean of 300 per 100 mL for any sample event (a set of three samples) or a 30-day average mean of over 130 per 100 mL. In 2018, there were no reported closures. Beach monitoring results can be found on the City's website at <u>marquettemi.gov/</u><u>municipal-utilities/</u>. ## Off-Leash Area Permits

The City's off-leash area, located at Tourist Park, is open to the public from Nov. 1 through April 30 each year.

Anyone interested in obtaining an OLA permit can pick one up at the City Clerk's Office in City Hall. You must bring your current dog license. If you don't have a current dog license, the Clerk's Office can issue you one upon presentation of an upto-date rabies vaccination certificate. Dog licenses cost \$8 for one year and \$20 for three years (if the animal is not spayed or neutered, the cost is \$16 and \$40). All licenses expire with the rabies expiration and must be renewed at that point. Licenses are required by state law for all dogs and cats even if they don't leave the owner's property.

Annual fees for the OLA permits remain unchanged from the previous season, City residents will pay \$15 per dog and nonresident fees are set at \$20 per dog.

### Primary Election Recap More than 4,200 City of Marquette residents cast votes in this

More than 4,200 City of Marquette residents cast votes in this year's August Primary election. Voters made choices in primary contests on both local and state levels, including in races for City Commission and Governor. Locally, millage proposals concerning Senior Services, Search and Rescue and Central Dispatch all passed.

In the City Commission primary, four candidates, Margaret Brumm, Jenn Hill, Mike Plourde and Jenna Smith (pictured left to right below), moved on to the November General election, where two will secure three-year seats on the City Commission.



## General Election Preview

The City Clerk's Office is now busy preparing for the November General Election, scheduled for Tuesday, Nov. 6.


Locally, Novembers ballot will include contests for the Marquette City Commission and Marquette Board of Light and Power, as well as for Michigan's 109th State House seat and 38th State Senate District.

Statewide, voters will make choices in the race for Governor, as well as for U.S. House of Representatives and U.S. Senate. There may also be several statewide proposals on the November ballot.

In order to vote in November, citizens must be registered by Tuesday, Oct. 9. You can check your registration status online at <u>www.michigan.</u> <u>gov/vote</u>.

## Are You in the Best Prescription Drug Plan for 2019?

Each year, Medicare beneficiaries have an opportunity to enroll in a prescription drug plan for the new calendar year. While individuals may stay with their current plan, the Michigan Medicare/Medicaid Assistance Program (MMAP) recommends reviewing your options each year.

Anyone who joined a Medicare prescription drug plan last year, will soon receive an annual notice of change from the company with which they have drug coverage. Read this carefully as this notice will identify whether the plan is changing their premiums, co-pays, deductibles and/or the medications they will cover. You will need to make sure that the medications you are currently taking will still be covered by your plan in 2019. If you need help understanding the notice, call a MMAP counselor for assistance.

Beneficiaries should take the time to answer these questions:

COST: Will your premium and costs change significantly in 2019?

COVERAGE: Do you need more coverage in 2019? Will the prescriptions you are taking be covered by your current plan in 2019?

CUSTOMER SERVICE: Are you satisfied with your plan's service?

OPTIONS: Are there better plans available for my specific needs?

Open enrollment begins Oct. 15 and ends on Dec. 7. This is the time to change plans, if you chose, for the 2019 calendar year. Beneficiaries who did not join a Medicare drug plan during their initial open enrollment period may also now apply for a drug plan.

The social workers at the Senior Center are certified MMAP counselors and are well-trained in the Medicare drug program. They provide assistance and counseling to Medicare beneficiaries and their families at no charge. MMAP counselors do not sell or endorse any insurance plan. MMAP Counselors can also determine if you are eligible for programs that may assist you in paying your Medicare costs. Call the Senior Center today to schedule an appointment at 906-228-0456.

The 2018 Fire Prevention Week campaign, "Look. Listen. Learn. Be aware. Fire can happen anywhere", works to educate people about three basic, but essential, steps to take to reduce the likelihood of having a fire and how to escape safely in the event of one.

"LOOK" for places a fire could start. Take a good look around your home. Identify potential fire hazards and take care of them.

"LISTEN" for the sound of the smoke alarm. You could have only minutes to escape safely once the smoke alarm sounds. Go to your outside meeting place, which should be a safe distance from the home, where everyone should know to meet.

"LEARN" two ways out of every room and make sure all doors and windows leading outside open easily and are free of clutter.



#### About Fire Prevention Week

Since 1922, the NFPA has sponsored the public observance of Fire Prevention Week. In 1925, President Calvin Coolidge proclaimed Fire Prevention Week a national observance, making it the longest-running public health observance in our country. During Fire Prevention Week, children, adults and teachers learn how to stay safe in case of a fire. Firefighters provide lifesaving public education in an effort to drastically decrease casualties caused by fires.

Fire Prevention Week is observed each year during the week of Oct. 9 in commemoration of the Great Chicago Fire, which began on Oct. 8, 1871, and caused devastating damage. This horrific conflagration killed more than 250 people, left 100,000 homeless, destroyed more than 17,400 structures and burned more than 2,000 acres of land. ## 2018 Fall Yard Waste & Brush Collection

Properties paying the "Solid Waste" fee on their monthly utility bills (green bag or cart users) are eligible to dispose of yard waste through this collection. Owners and tenants of properties not paying the fee should contact their regular waste hauler for service. This service is supported by fees, not taxes.

All residents are asked to observe the following rules to provide for a safe, efficient cleanup:

1. These collections are for brush, leaves, grass clippings and garden debris only. NO rubbish is allowed. All collected material will be composted. Material is not to be placed curbside more than one week prior to pick up date. Material MUST be placed curbside prior to 7 a.m. of the scheduled pick up date. If crews are ahead of schedule, they will return on your scheduled day to collect.

2. Pile yard waste on the lawn next to the street edge, NOT in the gutter or on street pavement. Keep yard waste in front of your own property. Do NOT pile on vacant adjacent properties. Motorists are asked to avoid parking in positions that block access to leaf piles or they will not be picked up.

3. Brush will be collected Oct. 22–26. The volume from each property is limited to one pickup load, a pile approx. 12'L x 6'W x 5′H.

4. Crews will collect loose or paper landscaping bagged leaves Oct. 29 – Nov. 2. Crews will return to the same routes Nov. 5-9 and collect loose or paper landscaping bagged leaves again. If you choose to bag your yard debris, only paper landscape yard waste bags are permitted. Plastic bags will not be collected. Bags containing garbage or other rubbish mixed with the yard waste will not be collected.

5. The City will not collect material after the last date listed below for each route. Residents are asked to deliver it to the composting site at 1415 Pioneer Rd. The site is open Tuesdays from 3–7 p.m. and Saturdays from 9 a.m.- 1 p.m. The site closes Nov. 10 for the season, weather permitting. Notification of the exact date will be sent out via public service announcement. Any yard waste will be accepted but brush will be limited to one pickup load per day. Proof of solid waste fee payment and ID is required for admittance.

The following are dates of the City of Marquette's brush and leaf collection. Crews will collect brush during week one and leaves (bagged or loose) during weeks two and three.
