Rental Registration Reminder

As a reminder to all landlords, property managers and rental tenants, City Code requires that all rental properties within the City of Marquette be registered, inspected and certified. A valid certificate of compliance issued in the name of the current owner must be posted in the rental unit. Certificates are not transferrable. When ownership changes it is the new owner's responsibility to register the property within the required timeframe. Failure to comply may result in citation.

Third St.

Property owners and managers are responsible to maintain safe rental properties for their tenants. Should an issue arise, tenants are encouraged to contact their landlord and work with them to resolve the issue. Should a safety issue be present that is left unresolved, the Fire Marshal is available to conduct tenant complaint inspections. Message from Mike

Hello everyone and welcome to fall and almost winter in Marquette. I say almost winter because, while most of us are still waiting for all the leaves to fall, many of us have had to shovel snow already. Also, welcome to all of our fall visitors in the form of NMU students. We here at the City are going to do our best to make sure that your NMU experience is a good one.





As most of you are probably aware, we've experienced another of our infamous fall storms that has eroded a significant part of our shoreline along Lake Superior north of Fair Avenue. For those that are not familiar with all of our street names, this length of roadway begins near Shiras Park (Picnic Rocks) and travels north for about a mile and a half. The most significant erosion occurred in the first half mile north to Wright Street. At one time there was a significant beach

along this stretch but, because of the erosion, the beach has been eliminated in many areas and the water's edge is virtually next to the roadway at many points. There are several different causes for this situation but I won't go into that here.

The good news is that the City Commission has taken action to stabilize the shoreline and protect the roadway that we all understand is important to this community. Some people may disagree on the importance of the roadway, but from experience I can assure you that the public sentiment is all about keeping that access open.



Overall, City Staff, along with the City Commission, is very aware of the importance of public access to our shoreline. We also understand that access comes in several forms that include, but are not limited to, walking and driving. We want everyone to enjoy the beauty of Lake Superior in the manner that benefits them. Now go out and enjoy the fall.

Outgoing City Commissioners

Commissioner Dave Campana and Mayor Pro Tem Sarah Reynolds have reached their term limits and will be leaving office in November. They were both elected to the City Commission in 2013 and reelected in 2016.

Commissioner Campana is a native of Crystal Falls, Michigan, and has been a resident of Marquette since 1981. Commissioner Campana served as the City Mayor from November 2015-November 2017 and again from January-November 2018 after the passing of Mayor Tom Baldini.

Mayor Pro Tem Reynolds moved to Marquette in 2003 to attend Northern Michigan University and served as a member of the Marquette Housing Commission prior to her election to the City Commission. Mayor Pro Tem Reynolds has served in her current role twice; once from November 2015- November 2016 and again from November 2018 until present.





Winter Tax Information

Winter Property Tax Statements will be mailed to City residents on Nov. 27. Tax collection begins Dec. 1 and payments are accepted without penalty through Feb. 14, 2020. Tax information can be accessed 24/7 on the City's website <u>marquettemi.</u> gov and is free to the property owner. Non-property owners are charged a \$2 lookup fee.

Holiday Closure

City offices located at Marquette City Hall, 300 W. Baraga Ave.; Lakeview Arena, 401 E. Fair Ave.; the Municipal Service Center, 1100 Wright St.; and the Marquette Arts and Culture Center, 217 N. Front St. (Peter White Public Library) will be closed Nov. 28-29, Dec. 24, 25, 31 and Jan. 1 for the Thanksgiving, Christmas and New Year's holidays. The Fire, Police, Public Works and Municipal Utilities Departments will remain open and staffed during this time.

Manager Open Office Hours

City Manager Mike Angeli holds community office hours on the second Wednesday of each month, from 10 a.m. until noon in the main floor conference room. The next community office hours sessions are scheduled for Nov. 13 and Dec. 11.

The meetings are intended to provide informal opportunities to discuss issues within the community, and to give citizens a chance for direct dialogue with City staff about interests and concerns.

Compost and Rubbish Site Schedule

The City of Marquette compost and household rubbish site at 1415 Pioneer Rd. is closing for the season. The last dates for rubbish drop-off are Nov. 4, 6 and 9. The last dates for compost drop off are Nov. 5, 9 and 12. These dates are weather permitting and are not guaranteed. The site will reopen in the spring depending on the weather.

A driver's license and current City water bill showing the payment of a solid waste fee for your property is required for admittance to the site. Residents in rental units using the green bags or carts who do not have a water bill in their name need to contact their landlord to file the rental registration form with the Public Works Department showing a list of tenants eligible to use the site. The form and up to date information on the compost and rubbish site can be found at www.marquettemi.gov/garbage.

Off-Leash Area

The City of Marquette's off-leash dog park is now open for the season. Permits for the park can be purchased at the City Clerk's office, located in City Hall at 300 W. Baraga Ave. City residents can purchase a season-long permit for \$15, while the cost for non-residents is \$20. Permits will only be granted if the dog has a valid Marquette County Dog License; these licenses are also sold at the City Clerk's office, in addition to the County Clerk's office and several local vet clinics.

The off-leash park is located in Tourist Park and is open each year from Nov. 1 through the end of April.

Landfill Permits Available

Applications may be downloaded from the City's website marquettemi.gov or picked up in the City Treasurer's office.

Commercial Haulers: Permits expired on Oct. 31. Renewal applications were mailed in October. The permit fee of \$65.00 is for a one-year period from November to October. New haulers may be required to also provide a deposit of up to \$1,000 with their application.

Residential Customers: The application fee for residential permits is \$10 and the permit period is for one week, Monday through Friday. Items such as shingles, tires and construction debris can be hauled to the landfill. This service is only for City of Marquette property owners.

Elections

In addition to the 2019 General Election on Nov. 5, the City Clerk's Office will be working to prepare for the 2020 Presidential Election cycle, which begins almost immediately. The coming year will bring at least three elections: the March 10 Presidential Primary, the Aug. 4 Primary Election and the Nov. 3 Presidential Election. While voter turnout is typically much higher during a Presidential Election cycle, recent changes to State law, spurred by the 2018 adoption of Proposal 3, may lead to an even higher-than-usual turnout.

In December, staff will mail applications for absentee ballots to those residents on the permanent absentee voter list (about 1,700). Voters that return these applications will receive ballots for the March Presidential Primary; those will be mailed out near the end of January. Applications for ensuing elections will be sent out a couple of months in advance of each. It's important to note that under State law, a voter must submit a signed application each time they would like an absentee ballot for an election.

Adult Use Marijuana

On Oct. 15, the City Commission approved Ordinance 682 allowing for adult use marijuana establishments within the city limits. The City Commission and City staff developed this ordinance over the course of the past year after Michigan voters chose to legalize recreational marijuana with a statewide ballot initiative in November 2018. The Michigan Regulation and Taxation of Marihuana Act (MRMTA) was put into effect during December following the passage of the ballot initiative; however, licensing of recreational establishments was delayed a year to give the State sufficient time to develop and implement a regulatory framework.

The Commission chose to opt out of the recreational law this past February due to a lack of clarity from the State government on the direction and manner of licensing and regulation of marijuana establishments. During this time, the Commission held a public forum to hear resident views on the new law and potential establishments within the City boundaries. In July, the newly established Marihuana Regulatory Agency (MRA) released emergency rules for the recreational market in order to start accepting applications for licenses this month (November).

After the adoption of the emergency rules by the MRA, City staff drafted an ordinance to regulate establishments within the City limits. A City Commission work session was held on Sept. 4 to discuss how many of each of the 11 license types would be allowed in the draft ordinance. On Sept. 9, the Commission voted to establish no limits to the number of licenses. The draft ordinance was then able to move onto a public hearing on Oct. 15.

After the public hearing, the City Commission discussed the inclusion of buffer zones around identified areas of concern. The ordinance was amended to remove daycare facilities, City parks and other marijuana establishments from the buffer list but retained 500 ft. buffers around schools, religious institutions and state licensed substance abuse disorder programs, as well as areas zoned exclusively for residential use, and was passed with a 4-3 vote.

The effective date of this ordinance is March 1 and there will be an extensive planning process leading up to this date to accommodate marijuana establishments in the Land Development Code (LDC). The LDC changes will be discussed in Planning Commission work sessions on Nov. 12, Nov. 19, Dec. 3 and Dec. 17 with a Planning Commission public hearing planned for Jan. 7. The Commission will review the Planning Commission's changes at a public hearing on Feb. 24. Please note, these dates are subject to change and up-to-date information, along with the full text of Ordinance 682, a timeline of the public process to date and a draft zoning map with buffers, is available at www.marguettemi.gov/marijuana.

2019 Construction Season, End of Season Update


The 2019 Construction Season is nearing completion. Most projects are completed except for minor punch list work. The 2019 construction season also included completing projects from 2018. Below are some of the projects that were designed and/or administered by the Engineering Division and their current status.

2018 Street Improvements and Maintenance Project(SIMP): This project was awarded to Oberstar, Inc. and construction started on July 23, 2018. The underground portion of this project was completed in 2018 and the milling and paving portion of the project was completed in the spring of 2019. The delay was the result of a labor dispute between the Michigan Infrastructure & Transportation Association and the Operating Engineers Local 324 union.

2019 Street Improvements and Maintenance Project (SIMP): This project was awarded to Oberstar, Inc. and construction started on June 6. All work is complete.

Sidewalk Repair, Replacement and Extension: This project was awarded to Arrow Construction. Construction started on July 1 and all work is complete.

Third Street Reconstruction (Fisher to Baraga), Front Street Reconstruction (Arch to Michigan), Front Street Reconstruction (Ohio to Hewitt), Altamont Street Reconstruction (Blemhuber to McMillan): This group of street reconstruction projects was awarded to Oberstar, Inc. Construction started on April 15 and all work in complete.

Kaye Avenue Reconstruction (Presque Isle to Third), Front Street Reconstruction (Park to Magnetic), Park Street Reconstruction (Lee to Fourth): This group of street reconstruction projects was awarded to Smith Construction. Construction started on July 2 and the projects are substantially complete. The contractor is currently addressing punch list items.

Lighthouse Park Project: This project was awarded to Oberstar Inc and construction started on May 13. All work is complete.

200 Block of West Kaye Avenue Water Main Construction: This was an unanticipated project that was required due to a failing one inch galvanized water line that serviced three homes. This line was replaced by an eight-inch water main. The project was awarded to Oberstar, Inc. and construction is complete.

Hawley Street Ditch Relocation Project: The portion of this project within the City right-of-way is currently starting. Bacco Construction is the prime contractor. Work is expected to be completed in the fall of 2019.

Sewer Cleaning and Televising: A request for proposals (RFP) was issued for this project. U.P. Rubber Company was selected for the work. This year's portion of the project is almost complete.

New MDDA Executive Director

The Marquette Downtown Development Authority (MDDA) is pleased to announce their new Executive Director, Rebecca Salmon, who began her new position on Monday, Sept. 30, after the retirement of long-standing Executive Director, Mona Lang. Salmon has been with the MDDA for 10 years, serving most recently as Assistant Director, and feels her tenure with the organization has prepared her well for assuming the leadership role. "Over the past decade, I've seen the growth of the organization and the downtown and am proud to have been a part of its transformation. I look to continue our forward progress in the revitalization of downtown, along with the MDDA Board and staff, the City of Marquette, downtown business and property owners and valued partners," said Salmon. MDDA Downtown Plan

The Marquette Downtown Development Authority (MDDA) has received a \$30,000 technical assistance grant from the Michigan Economic Development Corporation (MEDC) which will be used to create a comprehensive Downtown Plan. Once completed, the plan will serve as a guiding document moving forward, identifying strategic recommendations for downtown improvements as well as actionable steps for implementation.

"We will be working on the plan with a consultant firm, SmithGroup, along with other key contributors, to evaluate several proposed initiatives," said Salmon. For example, the MDDA has conducted a number of studies in recent years, including the Third Street Corridor Sustainability Plan and the Baraga Avenue Place Plan. One of SmithGroup's objectives is to compile these studies to create a cohesive vision for Downtown Marquette. The Downtown Plan will also focus on updating the 2013 Parking Study, which includes analyzing current parking management practices and conducting a feasibility analysis of building a new parking structure downtown to address the downtown's changing parking environment and better serve its various user groups. Other initiatives include identifying potential redevelopment sites throughout downtown and assessing the best approach for funding services and improvements in the Third Street corridor.

Work on the plan will start over the winter, with an anticipated completion by June 2020. "We anticipate engaging stakeholders in input sessions and presenting our final plan to the public upon completion," Salmon said. "This plan will help to address some of the challenges we currently face and provide a clear vision for the future of Downtown Marquette." Complimentary Holiday Parking

In celebration of the holiday season, enforcement of the metered parking and two-hour customer parking areas will be suspended throughout the downtown district Monday through Friday after 3 p.m. beginning Thursday, Nov. 14 and ending Wednesday, Jan. 1. Visitors to downtown may park without restriction after 3 p.m. in any of the public parking spaces within the district except those reserved for handicapped, 24-hour reserved or loading zones. This includes North Third Street, the lower and upper level of the Bluff Street Parking Ramp, Commons lot, Main Street lots, Lakeshore Boulevard lot, Rock Street lot, East Baraga Avenue lot and the Spring Street lot. The courtesy parking is offered compliments of the Marquette City Police Department and the Marquette Downtown Development Authority.





Downtown Façades Transformed

Several downtown properties have been transformed in recent months, thanks to a collaboration between the property owners, the Marquette Downtown Development Authority (MDDA) and the Michigan Economic Development Corporation (MEDC). The projects are part of a Downtown Façade Improvement Grant Program administered by the MDDA and generously supported through a \$300,000 grant from the MEDC as part of their Façade Restoration Initiative pilot program. Along with \$30,000 contributed by the MDDA, the \$330,000 in façade grant funding has inspired \$865,000 in downtown property investments. "The results have been dramatic and exciting to witness," said MDDA Executive Director, Rebecca Salmon. "We've seen new life breathed into tired facades, innovative designs brought to fruition and historical elements masterfully restored. This program is a testament to what can be accomplished through public-private partnerships for the betterment of Downtown Marquette."

The series of projects are in various stages of construction, with some underway and others having been completed. To date, the following properties have completed their façade improvements: Great Northern Title & Abstract, Third Base Bar, Third Street Bagel and Veridea Group. Several others, including Be kind, LLC, Breakers Roadhouse, The Preserve, Superior Hearing Aid Center and Symbios, LLC, are currently in progress. "We look forward to seeing the completed projects in coming weeks," said Salmon.


