



Winter Boat Storage

The boat owner must have prior approval for vessel storage from Community Services Department – Parks and Recreation Division, 401 E. Fair Ave., Marquette, MI 228-0460.

A form is available at the Lakeview Arena Parks & Recreation Office.

FEES ETC.:

- Fees: City of Marquette Residents: \$ 1.10 per sq. ft. Non-Residents: \$1.65 per sq. ft.
- Fees must be paid at time application is handed in and prior to storage of boat.
- Dates of Storage: **October 1, 2020 – May 15, 2021**. No boats may be stored before the October 1 date or after the May 15 date - no exceptions. Any boats stored after the designated storage dates shall be subject to daily transient fees.
- Based on square footage of boat – not time stored. Owner may record the measurement on the application. The fee is based on size reported. Vessel will be measured by staff after placement to verify length.
- If vessel is stored on a trailer, the trailer must have a valid license plate and registration.
- If vessel is place on a cradle, the cradle must have contact information located on the cradle, including name, address, and phone number.
- Applicant must have completed application and provide proof of insurance before fees will be accepted and approval given to store vessel.
- City will issue a permit tag which owner shall affix to the cradle or trailer. The permit tag should be placed where it is clearly visible.

Winter Storage Rules Only:

- Must have completed application submitted to Parks and Recreation office.
- Application must have signed authorization prior to storage of boat.
- Fees: City of Marquette residents \$1.10 per sq ft. Non Residents \$1.65 per sq ft. Fees must be paid before or at time of storage of boat (checks payable to City of Marquette).
- Square footage includes full overall length and overall width of the boat and the trailer (if applicable). From the tip of the bow spirit or pulpit to the tip of out drive, motor, swim platform or rudder. City staff will verify measurement for proper fees.
- Boats are to be stored in the designated storage area only.
- Must attach proof of insurance (**\$100,000.00** for each person injured or killed, not less than **\$100,000.00** for the injury or death of one or more persons in any one occurrence, and **Property** damage insurance in the sum of not less than **\$300,000.00**).
- City will issue owner a permit tag which shall be affixed to the cradle or trailer and clearly visible.
- **Under no circumstance shall any maintenance be allowed including welding, painting, fabrication, or mechanical services.**
- **Dates of storage: October 1, 2020 – May 15, 2021 –no early/late storage (Any boats stored before or after the designated storage dates shall be subject to daily transient fees.)**
