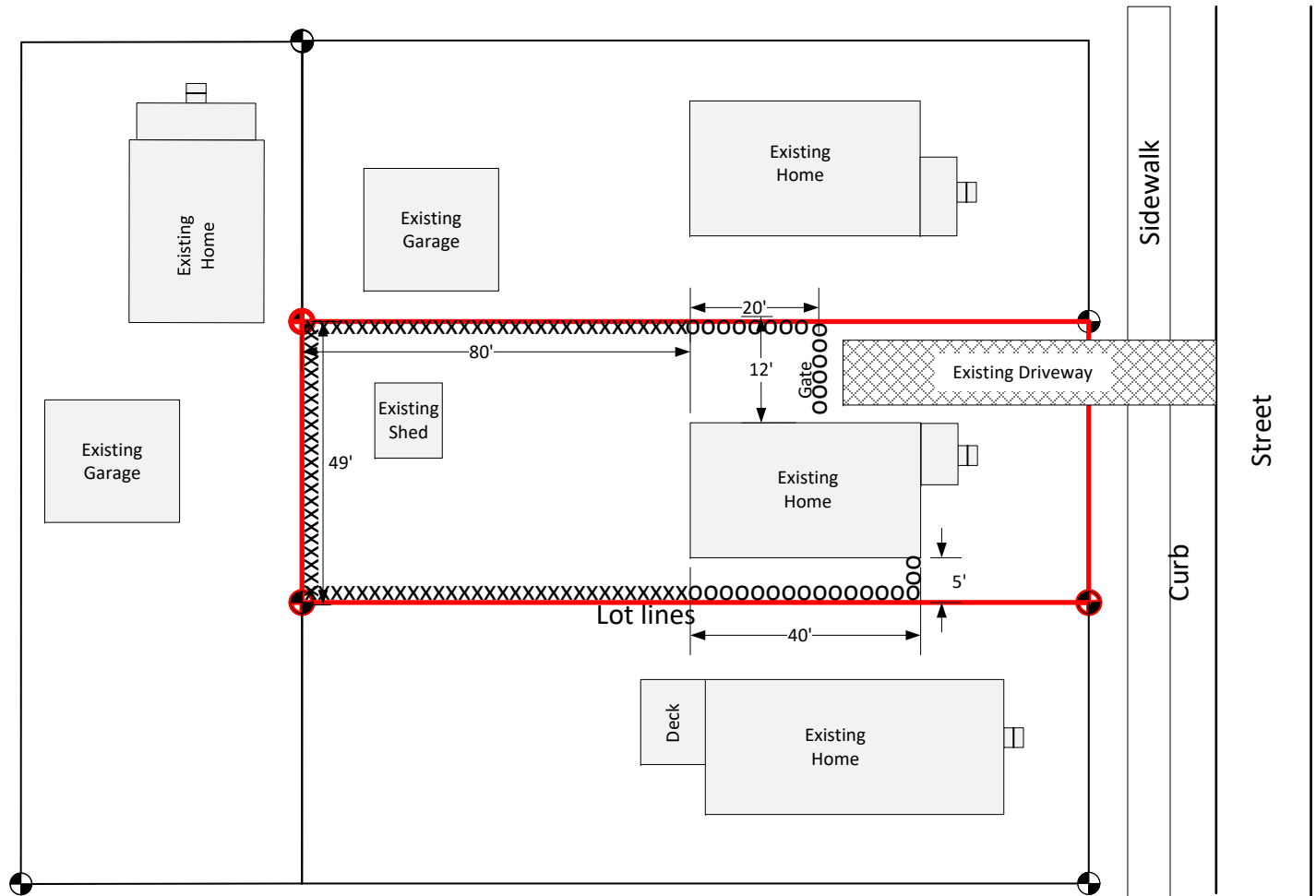

SAMPLE PLOT PLAN FOR YOUR REFERENCE
